**INFORMATION ABOUT APPLICATIONS AND SUPPORTING DOCUMENTS  
REQUIRED FOR THE RENEWAL OF SUITABILITY CERTIFICATE**

(article 20 of decision 18/809/21.2. 2018 of the Board of Directors of the Hellenic Capital Market Commission "Suitability Certification of natural persons providing services in accordance with the provisions of article 93 of law 4514/2018 (Government Gazette A '14 / 30.1.2018) »)

**I. WHEN THE APPLICATION IS SUBMITTED COLLECTIVELY BY A COMPANY** (article 1 of Decision 18/809/21.2.2018 of the Board of Directors of the Hellenic Capital Market Commission) on behalf of the persons working for the company or cooperating with it the following documents shall be submitted:

1. **[Application form for participation in the exams for the renewal of suitability certification](#)** signed by the candidate himself or the company

or

**[Application form for participation in training seminars for the renewal of suitability certificate](#)** signed by the candidate himself or the company

2. **Company's attestation** to the Hellenic Capital Market Commission in accordance with Article 7(1) of decision 18/809/21.2.2018 of the Board of Directors of the Hellenic Capital Market Commission, serving as a solemn declaration under Law 1599/1986 that the company has checked the minimum personal reliability requirements of the certification candidates, who are employed by the company or cooperate with it. For this purpose, the company obtained a copy of the general-use criminal record and a solemn declaration by every candidate, with verification of the authenticity of his/her signature, concerning the

non-initiation of disciplinary proceedings and the non-imposition of sanctions for any offence under Article 5(B) or a similar legal provision outside the territory of Greece.

**3. Receipt/Deposit of payment of the certification fee.** The certification fee amounting to 30 Euros shall be payable to the account of the Hellenic Capital Market Commission at the Bank of Greece (IBAN: GR 59010 0024 0000000000 262154).

***Attention:** The candidates are kindly requested to pay attention to the following guidelines concerning the certificate fee:*

*a) a stamp payment of 2.4% is further required on the amount of 30 Euros.*

*b) It is required to indicate the candidate's name on proof of deposit, even if the amount is paid by the company for which the candidate works or cooperates with.*

The application form is considered complete and acceptable by the Hellenic Capital Commission only if it is fully and correctly completed, signed (by the company or the candidate) and is accompanied by all the required supporting documents, mentioned above. Once the deadline for submitting supporting documents has expired, the application form submitted will not be accepted regardless of the reason for non-timely submission.

**II. WHEN THE APPLICATION IS SUBMITTED BY A NATURAL PERSON** the following documents shall be submitted:

1. [Application form for participation in the exams for the renewal of suitability certification](#) signed by the candidate himself.

**or**

[Application form for participation in training seminars for the renewal of suitability certificate](#) signed by the candidate himself.

2. **Solemn declaration by the candidate** (under Article 8 of Law 1599/86) with verification of the authenticity of his signature concerning the non-initiation of disciplinary proceedings against him / her and the non-imposition of sanctions for any offence of capital market legislation.
3. **Receipt/Deposit of payment of the certification fee.** The certification fee amounting to 30 Euros shall be payable to the account of the Hellenic Capital Market Commission at the Bank of Greece (IBAN: GR 59010 0024 0000000000 262154).

**III. WHEN THE APPLICATION IS SUBMITTED FOR RENEWAL WITHOUT PARTICIPATING IN EXAMS OR TRAINING SEMINARS** collectively by a company or by a natural person the following documents shall be submitted:

1. [Application form the renewal of suitability certificate without participating in exams or training seminars](#), signed by the candidate or the company for which the candidate works or cooperates with.
2. [Solemn declaration by the candidate](#) (under Article 8 of Law 1599/86) with verification of the authenticity of his signature concerning the non-initiation of disciplinary proceedings against him / her and the non-imposition of sanctions for any offence of capital market legislation.
3. **A Certificate of professional experience** from the employer, setting out clearly and in detail the subject and duration of engagement of the candidate including the Employer Registration Number.

or

**Certificate of cooperation** setting out clearly and in detail the subject and duration of cooperation between the candidate and the company referred to in paragraph 4 of Article 7 of law 4099/2012, serving as solemn declaration (under Article 8 of Law 1599/86).

4. **An insurance agency certificate** for the period of time for which the employment relationship of the candidate is verified by the company issued the professional experience certificate or the employment sector in case of cooperation.
5. **Receipt/Deposit of payment of the certification fee.** The certification fee amounting to 30 Euros shall be payable to the account of the Hellenic Capital Market Commission at the Bank of Greece (IBAN: GR 59010 0024 0000000000 262154).
