Στα πλαίσια της Ετήσιας Συνόδου της IOSCO και του Συνεδρίου της Επιτροπής Κεφαλαιαγοράς που θα πραγματοποιηθούν στις 29 Μαΐου 2024, θα συζητηθούν, μεταξύ άλλων,

- **Προκλήσεις και προοπτικές στην πράσινη μετάβαση:** Ανάλυση των τελευταίων εξελίξεων και των προσπαθειών για βιώσιμη ανάπτυξη καθώς και προκλήσεις που συνδέονται με την χρηματοδότηση της και τα σχέδια μετάβασης.
- **Προστασία των επενδυτών:** Εστίαση στην προστασία των επενδυτών, με ιδιαίτερη αναφορά στα φαινόμενα διαδικτυακής απάτης.
- **Τεχνολογικές εξελίξεις στις αγορές κεφαλαίων:** Θέματα που αφορούν τους τομείς Fintech, των κρυπτοστοιχείων, αγορών ψηφιακών στοιχείων, με έμφαση στις τάσεις και προκλήσεις που αντιμετωπίζουν οι επενδυτές.
- **Χρηματοπιστωτική σταθερότητα και αγορές κεφαλαίων:** Επίκαιρα θέματα χρηματιστηρίων, τιτλοποιήσεων, αναδιαρθρωμένων δανείων και άλλα.
