# **INFORMATION PROVIDED TO DATA SUBJECTS (Contractors)**

# (Articles 13 and 14 of the General Data Protection Regulation)

This notice concerns natural persons who undertake the execution of «service contracts» for the supply of works, goods or services, in accordance with the applicable legislation.

## Data Controller

HELLENIC CAPITAL MARKET COMMISSION - LEGAL ENTITY, with registered office in Athens (Kolokotroni 1, Athens 105 62), tel. 210-33.77.100.

The Hellenic Capital Market Commission was established as a legal entity (Greek law 1969/1991) and was organized by Greek law 2324/1995 with its registered office at Kolokotroni 1 & Stadiou, Athens 105 62, aiming to ensure the protection of investors and the orderly operation of the Greek capital market, operates exclusively in the public interest, and in general processes personal data which is necessary for the performance of a task carried out in the public interest or in the exercise of an official authority vested in it as a data controller.

The Hellenic Capital Market Commission, as controller, collects, maintains and processes personal data for specified, explicit and legitimate purposes and such data shall not be further processed in a manner incompatible with those purposes.

The Hellenic Capital Market Commission does not process special categories of personal data ("sensitive data") except where required by the applicable legislation in the exercise of its supervisory role.

## Purpose of processing and categories of personal data

The personal data collected, maintained and processed by the Hellenic Capital Market Commission as data controller is used for the purpose of signing and executing the contract for the award of works, the procurement of goods or services intended to serve the public interest, in accordance with the Greek law (4412/2016).

The personal data are collected and processed lawfully for the achievement of the abovementioned specified, explicit and legitimate purpose.

The personal data subject to the abovementioned processing is data relating to, but not limited to, the contractor's business details (identification details, tax details, insurance details), criminal records of natural persons in the context required by the applicable legislation (indicatively Article 80 of Greek law 4412/2016) and to the extent that the contractor is a natural person and not a legal person.

## Legal basis

The legal basis for the processing of the above personal data is the provision of Article 6 par. 1(b) of the GDPR, as the collection and processing are necessary for the execution of a contract to which the data subject is a party, as mentioned above.

# **Recipients**

The Hellenic Capital Market Commission collects, maintains and processes personal data submitted to it for supervisory purposes and does not further transmit it to third parties.

## Responsible authorized officers

Responsible officers on personal data issues are the Director of Financial Services Directorate and the Head of the Procurement Department of the Hellenic Capital Market Commission.

## Data Protection Officer

The HCMC has appointed a Data Protection Officer (DPO).

## Data retention period

The Hellenic Capital Market Commission keeps the personal data in its records relating to public procurement in accordance with the tax law and the applicable public procurement legislation.

## Rights of data subjects

According to Regulation (EU) 2016/679 of the European Parliament and of the Council (General Data Protection Regulation), any data subject has the right to submit a request to the controller for access, rectification, opposition, erasure, restriction of processing of data concerning it.

The abovementioned rights shall be exercised by submitting a written request addressed to the Hellenic Capital Market Commission and the competent Directorate of Financial Services (as above) of the Hellenic Capital Market Commission.

Any interested party has the right to lodge a complaint with the competent supervisory authority, the Hellenic Data Protection Authority.
