**INFORMATION PROVIDED TO THE DATA SUBJECTS**

**(Articles 13 and 14 of the General Data Protection Regulation)**

**Information provided to natural persons whose personal data is included in the documents submitted under the provisions of Greek law 3461/2006 on public proposals.**

This notice concerns the natural persons whose data is included in the documents submitted, within the framework of the provisions of Greek law 3461/2006 on takeover bids, to the Hellenic Capital Market Commission

**Data Controller**

HELLENIC CAPITAL MARKET COMMISSION - LEGAL ENTITY, with registered office in Athens (Kolokotroni 1, Athens 105 62), tel. 210-33.77.100.

The Hellenic Capital Market Commission was established as a legal entity (Greek law 1969/1991) and was organized by Greek law 2324/1995 with its registered office at Kolokotroni 1 & Stadiou, Athens 105 62, aiming to ensure the protection of investors and the orderly operation of the Greek capital market, operates exclusively in the public interest, and in general processes personal data which is necessary for the performance of a task carried out in the public interest or in the exercise of an official authority vested in it as a data controller.

The Hellenic Capital Market Commission, as the controller, as specified in Article 4 par. 1 point 7 of the General Data Protection Regulation (GDPR), collects, maintains and processes personal data for specified, explicit and legitimate purposes, for the performance of a task carried out in the public interest or in the exercise of official authority vested in the HCMC only in the exercise of its statutory powers and such data shall not be further processed in a manner that is incompatible with those purposes.

The Hellenic Capital Market Commission does not process special categories of personal data ("sensitive data") except where required by the applicable legislation in the exercise of its supervisory role.

In particular, in accordance with the provisions of Greek law 3461/2006, as in force, and the relevant decisions of the Board of Directors of the Hellenic Capital Market Commission, the Hellenic Capital Market Commission, as the controller, collects, maintains and may process personal data.

This data is collected :

- either directly from the persons submitting the relevant documents under the provisions of Greek law 3461/2006 on takeover bids.
- either through the legal persons making a takeover bid in accordance with Greek law 3461/2006.

### **Purpose of processing and categories of personal data**

The personal data collected, maintained and processed by the Hellenic Capital Market Commission as the controller in accordance with the provisions of Greek law 3461/2006, as in force and the relevant decisions of the Board of Directors of the Hellenic Capital Market Commission, is used within the framework of the HCMC's tasks for the supervision of compliance with the provisions of this law and the takeover bid procedure in general, in conditions of transparency, publicity and validity, as well as the strict compliance with the principle of equality of shareholders, for any matters relating to the consideration offered in a takeover bid, the procedure of the takeover bid, the content of the offer document, the information on the offeror's decision to make a takeover bid and the disclosure of the takeover bid.

The personal data are collected and processed lawfully for the achievement of the abovementioned specified, explicit and legitimate purpose.

The personal data subject to the above processing is data relating to, but not limited to, nominative individual information, identity details, contact details and receipts for payment of fees, tax identification number.

### **Legal basis**

The legal basis for the processing of the above personal data is the provision of Article 6 par. 1(c) of the GDPR, as the collection and processing of such data constitutes a legal obligation of the controller, as mentioned above.

### **Recipients**

The Hellenic Capital Market Commission collects, maintains and processes personal data submitted to it and does not further transmit it to third parties.

### **Responsible authorized officers**

The Director of Listed Companies and the Head of Continuous Information Department of the Listed Companies Directorate of the Hellenic Capital Market Commission are responsible for personal data issues submitted under the provisions of Greek law 3461/2006 on takeover bids.

### **Data Protection Officer**

The HCMC has appointed a Data Protection Officer (DPO).

### **Data retention period**

The Hellenic Capital Market Commission keeps the personal data in its records for at least 25 years with the possibility of further retention for archiving purposes in order to perform a task carried out in the public interest and/or in the exercise of an official authority entrusted to the Hellenic Capital Market Commission, as a controller.

### **Rights of data subjects**

According to Regulation (EU) 2016/679 of the European Parliament and of the Council (General Data Protection Regulation), any data subject has the right to submit a request to the controller for access, rectification, opposition, erasure, restriction of processing of data concerning it.

The abovementioned rights shall be exercised by submitting a written request by the interested party addressed to the Hellenic Capital Market Commission and the competent Directorate (as above) of the Hellenic Capital Market Commission (Department of Continuous Information of Directorate of Listed Companies of the Hellenic Capital Market Commission).

Any interested party has the right to lodge a complaint with the competent supervisory authority, the Hellenic Data Protection Authority.
