The Hellenic Capital Market Commission informs the public that it became aware of cases of fraudulent online trading platforms or websites where it is given misleading information (such as name, license number, G.E.MI. number, registered office, etc.) that are identical or similar to information of company, VIE FINANCE AEPEY, supervised by the Hellenic Capital Market Commission.

In particular, **VIE FINANCE AEPEY** has informed that it has no connection with the following fraudulent websites which claim to be its trademarks:
