The officers and representatives of PHAROS INVESTMENT ADVISORS AEED communicate with customers and any other third party **exclusively through their official e-mail addresses** (i.e. name of the person followed by “@pharosinv.com” without any other suffix) and through the official telephone lines stated on our website **www.pharosinv.com**. No person from PHAROS INVESTMENT ADVISORS AEED will communicate with any investor by using an e-mail account provided by other sources.

PHAROS INVESTMENT ADVISORS AEED intends to proceed to any appropriate legal action to stop and prevent the unauthorized use of the names and image of its shareholders and officers, as well as to report the above misleading practices to the competent capital market authorities.
