The Board of Directors of the Hellenic Capital Market Commission at its 927th/31.8.2021 meeting decided:

- To approve the prospectus for the mandatory public takeover bid of the company "TERNIALE LIMITED" to the shareholders of the company "IDEAL GROUP S.A.".
- To grant authorization to the company "VALUE BRIDGE SOLE SHAREHOLDER AEPEY", in order to provide the investment service of reception and transmission of orders in relation to the financial instrument (1) of Section C of Annex II of Greek law 4514/2018.
