PRESS RELEASE

The Board of Directors of the Hellenic Capital Market Commission at its 1050th meeting on 14.4.2025 decided:

- To extend the authorisation of "VIGOR FINANCE INVESTMENT SERVICES SOCIETE ANONYME" (LEI: 213800G1VHU71V9Z2L29) as regards the provision of investment service no. 7 of Section A (*placing of financial instruments without a firm commitment basis*) and ancillary service no. 3 of Section B of Annex I to Law 4514/2018 (*advice to undertakings on capital structure, industrial strategy and related matters and advice and services relating to mergers and the purchase of undertakings*) on financial instrument no. 1 (transferable securities) of Section C of Annex I to Law 4514/2018.
- To extend the AIFM authorisation under Law 4209/2013 of "IOLCUS INVESTMENTS SA" (LEI: 213800WBLTVLFX5HGK92), adding three additional strategies of Annex IV of Regulation 231/2013 as follows: (a) Fund of Funds, (b) Private Equity Fund and (c) Real Estate Fund.
- To suspend the redemption of UCITS units on 24 December 2025, a date that does not coincide with the official Athens Exchange Holidays for 2025.
