The Board of Directors of the Hellenic Capital Market Commission at its 947th/4.3.2022 meeting decided:

- To approve the prospectus for the mandatory bid of the company "CRYRED INVESTMENTS LIMITED" to the shareholders of the company "P.G. NIKAS S.A." to acquire all of their shares, in accordance with Greek law 3461/2006.
- To approve the prospectus for the optional public offering of the company "EM. KAR. S.A." to the shareholders of the company "KARAMOLEGOS BAKERY INDUSTRY S.A." in accordance with Greek law 3461/2006.
- To impose a total fine of € 8,000 on the company "ELGEKA S.A." for the infringement of the provisions of article 4 (paragraph 3) of Greek law 3556/2007, for not complying with IAS/IFRS standards when preparing the annual financial reports for the financial year 1.1-31.12.2020.
- To impose a total fine of € 4,000 on the company "UNIBIOS HOLDINGS S.A." for the infringement of the provisions of article 4 (paragraph 3) of Greek law 3556/2007, for not complying with IAS/IFRS standards when preparing the annual financial reports for the financial year 1.1-31.12.2017.
- To impose a total fine of € 5,000 on the company "NATIONAL SECURITIES S.A." for the infringement of the provisions of paragraph 1(c) of Regulation (EU) 565/2017, in combination with paragraph 5 of the same article, regarding internal audit mechanisms.
